City Grant writers Alma Gutierrez and Candy Hobbs informed the council on the Code of Conduct TDA form A1002: As a grant recipient of a TxCDBG contract, The City of Brackettville shall avoid, neutralize or mitigate actual potential actual or potential conflicts of interest so as to prevent an unfair competitive advantage or the existence of conflicting roles that might impair the performance of the Tx CDGB contract or impact the integrity of the procurement process.

City Grant writers Alma Gutierrez and Candy Hobbs informed the council on Section 504 Policy Against Discrimination based on Handicap and Grievance Procedures: In accordance with 24 CFR Section 8, Nondiscrimination based on handicap din federally assisted programs and activities of the Department of Housing and Urban Development, Section 504 of the Rehabilitation Act of 1973, as amended (29 U.S.C. 794), and Section 109 of the Housing and Community Development Act of 1974, as amended (42U.S.C 5309),

Alderman Charles Hall moved to approve to adopt Section 504 based on handicap policy TDA form A1004, seconded by Alderwoman Francisca Hernandez. All in favor. Motion carries.

16. Consideration and possible action on authorizing of City Administrator Nora Rivas to form and collaborate with individuals/ organizations on the completion of a section 504 self-evaluation document TDA form A1006.

City grant writers Alma Gutierrez and Candy Hobbs informed the council on the selfevaluation form which consist of questions like identifying individuals with disabilities or organizations and how they participated with the self- evaluation form.

Alderman Refugio Martinez moved to authorize City Administrator Nora Rivas to form and collaborate with individuals to complete self-evaluation document TDA form A1006, seconded by Alderman Charles Hall. All in favor. Motion carries.

City Grant writers Alma Gutierrez and Candy Hobbs informed the council on the City of Brackettville Fair Housing Policy: The City of Brackettville agrees to affirmatively further fair housing choice for all seven protected classes. Agrees to plan at least one activity during the contract term to affirmatively further fair housing and will introduce and pass a resolution adopting this policy.
