

ORDINANCE - 1991-202A

AN ORINANCE TO SET CHARGES FOR SECURITY GUARD REQUIRED AT ALL PUBLIC OR PRIVATE DANCES, OR ANY OTHER FUNCTION, WITHIN THE CITY LIMITS OF THE CITY OF BRACKETTVILLE, WHERE ALCOHOLIC BEVERAGES ARE TO BE CONSUMED.

WHEREAS, THE CITY COUNCIL of the City of Brackettville, deems it necessary for persons, or organization conducting public or private dances, or any other function within the city limits, where any alcoholic beverages to be consumed, be required to have two security guards; and

WHEREAS, THE charges for each security guards be set at \$35.00 per guard, payable within twenty-four hours prior to event or function at the City Hall office during working hours; and

WHEREAS, All private or public dances held from Sunday thur Friday nights will end at 12:00 P.M. and private or public dances held on Saturday nights will end at 1:00 A.M. or according to the Alcoholic Beverage Commission; and

WHEREAS, All person, persons, or organizations failing to have two security guards onduty on and pr will result in forfeit or rights to have the function and will be closed by the City of Brackettville Chief of Police; therefore

WHEREAS, THE CITY COUNCIL of the City of Brackettville, deems it necessary for persons, or organizations conducting public or private dances, or any other functions within the City limits, where any alcoholic beverages to be consumed, be required to have two security guards; and

WHEREAS, THE charge for each security guard to be set at \$35.00 per guard, payable within the twenty-four hours prior to the event or function at the City Hall office during working hours; and

WHEREAS, ALL private or public dances held from Sunday thru Friday nights will end at 12:00 P.M. and private or public dances held on Saturday nights will end at 1:00 A.M. or according to the Alcoholic Beverage Commission; and

Sunday thru Friday - 8:00 P.M. TO 12:00 P.M.
Saturday Nights - 9:00 P.M. TO 1:00 A.M.
(OR ACCORDING TO A.B. COMM.)

WHEREAS, ALL private or public dances or functions held within the City limits, commencing before specified schedule above, will pay an extra \$10.00 per hour per security guard; and

WHEREAS, ALL security guards must meet requirements set by City of Brackettville Chief-of-Police; and

WHEREAS, THE City of Brackettville will charge a 15.00 permit fee for the private or public dance or function being held within the City limits of the City of Brackettville.

WHEREAS, ALL person, persons, or organizations failing to have two security guards on duty on any private or public dance, or function, will result in forfeit or rights to have the function of dance closed by the City of Brackettville Chief-of-Police;

THEREFORE BE IT ORDAINED BY THE CITY OF BRACKETTVILLE THAT:

Effective this date all dances sponsors will have two security guards on duty at all public and private dances or any other function where alcoholic beverages are to be consumed, and that security charges be set at \$35.00 per security guard, plus extra charges where required, payable within twenty-four hours.

This Ordinance supersedes any and all previous Ordinances pertaining to public or private functions.

WHEREAS, ALL private or public dances held from Sunday thru Friday nights will end at 12:00 Midnight and private or public dances held on Saturday nights will end at 1:00 A.M. or according to the Alcoholic Beverage Commission; and

Sunday thru Friday - 8:00 P.M. TO 12:00 Midnight
Saturday Nights - 9:00 P.M. TO 1:00 A.M.
(OR ACCORDING TO A.B. COMM.)

WHEREAS, ALL private or public dances or functions held within the City limits, commencing before specified schedule above, will pay an extra \$10.00 per hour per security guard; and

WHEREAS, ALL security guards must meet requirements set by City of Brackettville Chief-of-Police; and

WHEREAS, THE City of Brackettville will charge a \$15.00 permit fee for the private or public dance or function being held within the City limits of the City of Brackettville.

WHEREAS, ALL person, persons, or organizations failing to have two security guards on duty on any private or public dance, or function, will result in forfeit or rights to have the function of dance closed by the City of Brackettville Chief-of-Police;

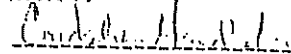
THEREFORE BE IT ORDAINED BY THE CITY OF BRACKETTVILLE THAT:

Effective this date all dances sponsors will have two security guards on duty at all public and private dances or any other function where alcoholic beverages are to be consumed, and that security charges be set at \$40.00 per security guard, plus extra charges where required, payable within twenty-four hours.

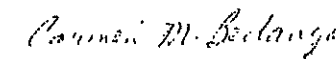
This Ordinance supersedes any and all previous Ordinances pertaining to public or private functions.

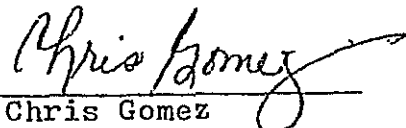

PUBLIC FUNCTION - DANCE ORDINANCE

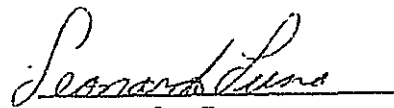
All public dances, where alcoholic beverages are consumed, to be held in the CITY LIMITS of Brackettville in a public building, city street, or on private property where a fee or donation is required to enter will be required to have at least one (1) security guard. Said security guard (s) must be identified and approved by the Chief of Police at least twenty-four (24) hours prior to the dance. If no security guard has been identified and approved by the Chief of Police at least twenty-four (24) hours prior to the dance it will be the duty of the Chief of Police to appoint a security guard to work the dance. Security guards will be paid by the person or organization conducting the dance. The fee for this service will be \$35.00 per guard. This fee must be posted at City Hall, during regular business hours, at least twenty-four (24) hours prior to the time the dance is to start. Failure to meet the requirements for providing a security guard as listed above will result in the forfeit of the right to have the dance and said dance will be closed on order of the Chief of Police.

All functions, where alcoholic beverages are consumed, held in a public place, will end by no later than 2:00 AM according to STATE LAW as provided by the TEXAS ALCOHOLIC BEVERAGE COMMISSION.

This ORDINANCE supercedes and replaces any and all previous ordinances pertaining to public and private functions and/or dances.
