MONTHLY REPORTS

13. Consideration and discussion of the monthly report presented by the Operations Supervisor Michael Falcon.

Installed 1700 foot water line on 2804. Continue to spray for mosquitos as well as brush and bulk pick-up throughout the City. Keeping arroyos mowed down and replaced the water pump at the water tower. We have several water and sewer taps that will be installed on Coffin, El Paso and Quintel streets.

14. Consideration and discussion of the monthly report presented by City Administrator Nora Y Rivas.

We have opened up the drive thru window at City Hall from 8 am - 5 pm. We continue to receive payments via phone, online and in the drop box. I applied for the Coronavirus Relief Fund from the Texas Division of Emergency Management for the amount of \$19,500.00 to cover the cost that the City endured during the pandemic. I received an

email from FEMA stating that we will be getting an additional \$5,000.00 from the flooding in 2018. On May 20, 2020 the Mayor and I signed the paperwork for the \$3,102,000.00 (three million one hundred two thousand dollars) loan from USDA. This money will be used towards the wastewater and water project. Once that money is used we will be using the grant that they City received for \$2,411,000.00 (two million four hundred thousand eleven dollars). On May 26, 2020 we got the first request of money from USDA and we paid the loan to The Bank & Trust for the amount of \$125,000.00. This money was owed to the Rosin Group, the engineer for this project. Money was also owed to Langley & Banack for their services. We will be submitting on a monthly basis a request to USDA to pay invoices as they are coming in from the projects.
