Additionally, our focus is to keep all citizens within Kinney County safe and healthy. As of today's date, there are zero confirmed cases within Kinney County. We want to encourage our citizens to stay home as much as possible. In the instance people have to leave their homes, please practice social distancing. At this point, there is not a shelter in place for Kinney County.

How to Protect Yourself and Others

We as the citizens of Kinney County must do our part to slow the spread of COVID-19 virus. This will happen only if each of us does our part as a community. There are various steps each of us can take in order to protect ourselves, our families, and our neighbors. Doing our part cannot be over emphasized especially with our surrounding communities increasing in number of confirmed COVID-19 cases. Doing our part may consist of:

- Practice social distancing
 - o Remain at least 6 feet away from anyone
- > Best practice is to not have gathering of more than 10 people according to the Center for Disease Control and Prevention (CDC).
 - o This will include in public areas, businesses, and private residences.
 - o Back yard gatherings of family and friends should not be 10 or more
 - o Do not plan and avoid parties or "get together's"
- > Stay home if you are sick or feeling sick and call your primary physician. You may also call a clinic, such as:
 - o United Medical Center in Brackettville 830.563.2311
 - o United Medical Center in Del Rio 830.774.5534
 - Uvalde Health Clinic in Uvalde 830.278.7105
 - o United Medical Center in Eagle Pass 830.773.5358
- ➤ If your physician has asked you to self-quarantine, ask questions such as:
 - o How long?
 - O What about people in my household?
 - o Can I go outside my house?
 - o Do you have any suggestions on how I get supplies?

- ➤ Only call 911 for medical emergencies that are not related to COVID-19
 - o Kinney County has limited resources and unnecessary calls place a strain on other emergencies within Kinney County

The pressures of COVID-19 may bring strain on our families and may also bring financial concerns.
